- I. Provided by-: OPPO Mobiles India Private Limited ("Company/OPPO");
- II. Description of Offer: Bundling Offer ("Offer")
- III. Eligibility Criteria: This offer shall be applicable only on purchase of "OPPO F19 Pro Plus (5G)/ OPPO F19 Pro (128 Gb)" (hereinafter referred "Device") together with either OPPO ENCO W11 or OPPO Smart band, through authorized offline stores and showrooms and Device activated during the offer period as mentioned hereunder.

For the sake of clarity, the offer shall be available on the purchase of either:

- 1. Device along with OPPO ENCO W11; or
