According to the UK REACH, OPPO is defined as a producer of articles and has done its best to meet requirements of UK REACH. Details are as follows:

Registration

According to New registration and Grandfathering EU Registration under UK REACH, companies have to collect information on the properties and uses of the substances they manufacture or import above one tonne a year, and submit a registration to the Agency(HSE). They should also assess the hazards of the substance and any potential risks presented by its uses. Registration applies to substances on their own, substances in mixtures (formulated products) and in certain limited cases to substances in articles. **As far as we know, OPPO does not apply this requirement.**

Notification

According to Article 33, any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1 % weight by weight (w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance.

OPPO has assessed the SVHC may be contained in this product above 0.1 % weight by weight (w/w).
